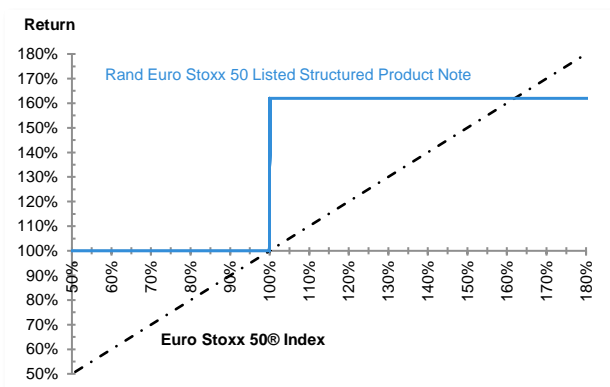
The Rand Euro Stoxx 50[®] Listed Structured Product Note ("Note") is a structured product issued by Investec Bank Limited ("IBL") and listed on the JSE Limited ("JSE").

The Note is a three year investment linked to the level of the Euro Stoxx 50[®] Index ("Index") with an effective rate of 17.4% per annum paid to the investor if the Index return be zero or positive at maturity (62% digital return). The return will be paid to the investor in ZAR - therefore no currency risk.

Summary of the investment offering

- 3 year equity investment linked to the performance of the Euro Stoxx 50[®] Index
- 100% principal protection in ZAR on the full investment if held to maturity and no credit event has occurred in respect of IBL
- Daily liquidity in normal market conditions provided on the JSE. Liquidity is provided by IBL, who undertake to act as sole market maker
- Daily pricing on the JSE under Investec's Warrant & Note program

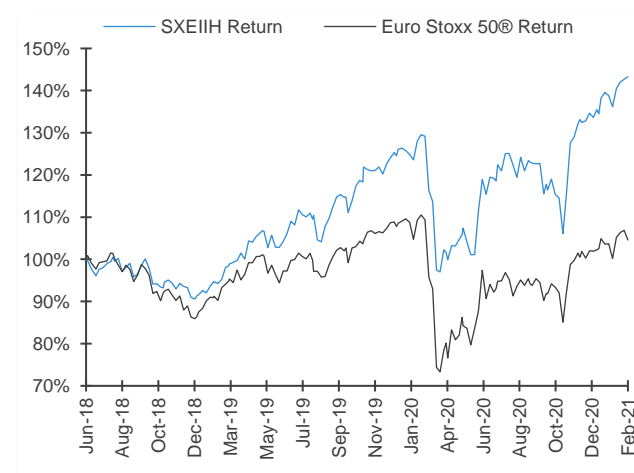
Payoff profile at expiry
