Investec Structured Return Note Listed Structured Product Note (“Note”) is a structured product issued by Investec Bank Limited (“IBL”) and listed on the JSE Limited (“JSE”).

A three year and one week investment linked to an increase in the level of the Euro Stoxx 50® Index (“Index”). Fixed 25.53% return in Rands should the Index return be zero or positive at maturity and a minimum 15% return if the Index performance is below initial Index level of 3,351.71

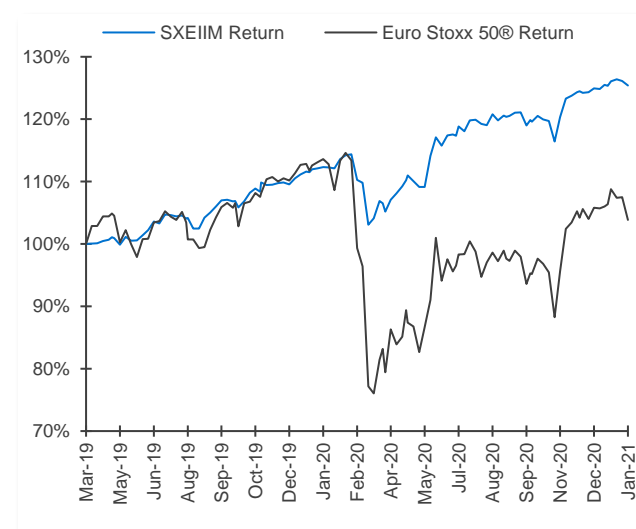
Summary of the investment offering
