The Investec SA Geared Growth Profile ("Geared Growth Profile") is a structured product issued by Investec Bank Limited ("IBL") and listed on the JSE Limited ("JSE").

The Geared Growth Profile is linked to the performance of a basket of listed South African Shares ("Share Basket"). The investment provides 142% participation in the growth of the Share Basket in Rand, with 100% capital protection at maturity.

## Summary of the investment offering

- 3-year investment linked to the performance of the Share Basket.
- The return will be calculated in Rand.
- The investor receives capital protection at maturity.
- Investment linked to the performance of an equally weighted basket of listed South African Shares. The Share Basket growth is calculated as the average of the price-only returns of the shares in the basket. However, if the closing share price on any day from Trade Date to the Valuation date has increased by 75% or more compared to the Initial Share Price on Trade Date, then the return of that share is replaced with 22% when calculating the Share Basket Return (observed daily).
- Earn 142% x growth of the Share Basket Return.
- Daily pricing provided on the JSE with a 1.0% bid/mid spread.
- Liquidity is provided by IBL, who undertake to act as sole market maker.
- Daily pricing on the JSE and monthly statements from your stockbroker.
