
The Investec USD Euro Stoxx 50<sup>®</sup> Autocall ("Autocall") is a structured product issued by Investec Bank Limited ("IBL") and listed on the JSE Limited ("JSE").

A maximum five-year, inward-listed investment linked to the performance of the Euro Stoxx 50® Index ("Index"). 11.25% Coupon in USD per annum, if Index is flat or positive. The Autocall will mature at the end of year 5, but may be subject to annual automatic call dates at the end of years 1, 2, 3 or 4. 100% downside protection on expiry provided the Index does not end below the barrier level.

#### Summary of the investment offering

- A 5 year investment linked to the performance of the Eurostoxx50 Index.
- The Autocall pays an 11.25% return p.a. in USD if the index is flat or above the initial index on an automatic call date. The automatic call dates are in year 1, 2, 3, 4 and at maturity.
