Donations to missionaries	Letter from official or recognized religious body
Maintenance	Strictly to father, mother, brother or sister in necessitous circumstances. Letter from magistrate/civic official
Monetary gifts and loans	None
Travel allowance	E-ticket and passport
Study allowance	Tuition fees: Letter/prospectus from institution plus confirmation of enrolment, invoice. Subsistence allowance, maintenance and other expenses require a breakdown of expenses on letter
Alimony and child support	Copy of Court Order

Services Rendered (Legal, accounting, management consulting, advertising, marketing research, medical, dental, educational services)	*By a non-resident Supply invoice Our Financial Surveillance Forex team may request an agreement.

Adjustments/reversals	Must supply previous trade reference
