The investment objective of the Listed Property Portfolio is to provide investors with a growing income stream that can translate into capital growth over the medium to long term.

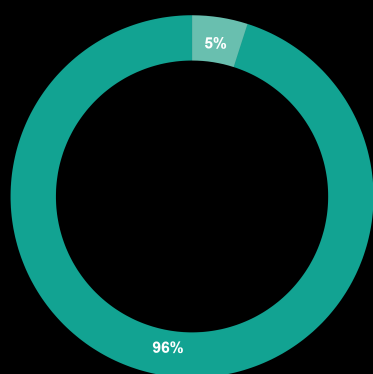
