Maturities Overview – Deposit Plans

Since our launch in 2008, our clients have enjoyed competitive returns from our Deposit Plans. Our Deposit Plans are deposits with Investec Bank plc. They are the same as a standard fixed term deposit account, except that instead of paying a guaranteed rate of interest, they pay interest linked to the performance of an index such as the FTSE 100. Just like a fixed term deposit account, our Deposit Plans are capital protected and eligible for the Financial Services Compensation Scheme.

The following is a summary of the maturity performance of our most popular Deposit Plans that have matured to date. For comparison purposes, we have benchmarked the returns of each Deposit Plan against the average 3 or 5 year fixed term deposit rate that was available at the time of investment.*
