Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

This product is an over the counter derivative (OTC) contract. It is used to hedge FX exposure.

Objective

A Release Forward obliges you to exchange an agreed amount of one currency for another currency at an agreed strike rate on the delivery date. However, movement in the currency rates down to an agreed limit rate will remove this obligation to leave you with the right, but not the obligation, to do so.

If the currency rate is at or below the strike rate at expiry, you are protected to exchange the agreed amount of one currency for another currency at the agreed strike rate on the delivery date.

If the currency rate is above the strike rate at expiry without having traded at or below the limit rate at any time during the window period, you are obliged to exchange the agreed amount of one currency for another currency at the agreed strike rate on the delivery date.

If the currency rate is above the strike rate at expiry having traded at or below the limit rate at any time during the window period, no exchange takes place under the product.

Illustrative terms are set out below, which are illustrative of the terms of the product but which do not reflect the exact terms you agree with Investec Europe Limited. The exact terms will be set out in an individual trade confirmation.

Holding period: 3 months

Intended retail investor

This product is intended for Irish retail investors who understand that the outcome of the product is dependent on the path of the currency rate during the holding period.

Term

The product is a bilateral agreement that cannot ordinarily be terminated unilaterally by either you or Investec Europe Limited. It is a product which is entered into for its term, although early termination may occur in the event of a default of either you or Investec Europe Limited. The product terms provide that if certain exceptional events occur (1) Investec Europe Limited may make adjustments to the product and/or (2) Investec Europe Limited or you may terminate the product early. These events are specified in more detail in the Terms and Conditions. The amount (if any) you receive or pay on such early termination is likely to be different from the scenarios described in this document.

What are the risks and what can I get in return?

Risk Indicator



The risk indicator assumes you keep the product until its delivery date. The actual risk can vary significantly if you end your product at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class.

What are the costs?

Cost over time

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the performance of the product. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, over the holding period. They include potential early exit penalties. The figures assume the notional value of the product is £10,000. The figures are estimates and may change in the future.

How long should I hold it and can I take money out early?

This product is designed to be held to the end of the holding period. It is not a product which can be easily sold or transferred. Early termination may occur in the event of a default or disruption situation or if you or Investec Europe Limited agree for it to be terminated early, in which case, early exit penalties may apply.
