The below details should be used for transferring US dollars by SWIFT/telegraphic transfer to a bank account held at Investec Bank (Channel Islands) Limited (the Bank). Please ensure that the remitting bank sends an MT103 to the Bank as we will not be able to apply funds without an authenticated SWIFT message. If they would like to send it directly, our SWIFT address is: GMGUGGSP. For all transfers please ensure that the valid account name, account number and/or IBAN are quoted and the remitter's full name, address and account number appears on the transfer. The Bank may not be able to apply funds that arrive without full details.
